If anyone should sue SBI for any of this money, I will, at SBI's request, and entirely at my expense and risk, appear in Court and defend SBI against the suit. If SBI has to pay any monies by way of judgment or settlement, I will pay that money, and will reimburse SBI in full for any and all reasonable expenses, including attorneys' fees, SBI may have incurred in connection with any such suit, claim, proceeding, etc.
